## DETAILS OF EACH DIRECT DEBIT PAYMENT OPTION:

### 1. Annual Payment

- 100% of your annual subscription plus any additional charges will be deducted from your nominated account on the 1<sup>st</sup> January via direct debit.

### 2. Half- Yearly Instalments

- 50% of your annual subscription plus any additional charges will be deducted from your nominated account on the 1<sup>st</sup> January via direct debit.
- The remaining balance will deducted from your nominated account on the 1<sup>st</sup> July via direct debit
- Please Note: A 5% instalment fee will be applied to your annual subscription.

### 3. Quarterly Instalments

- 25% of your annual subscription plus any additional charges will be deducted from your nominated account on the 1<sup>st</sup> January via direct debit.
- Three (3) more instalments equalling 25% each of your annual subscription will be deducted from your nominated account via direct debit on the following dates: 1<sup>st</sup> April, 1<sup>st</sup> July & 1<sup>st</sup> October.
- Please Note: A 7.5% instalment fee will be applied to your annual subscription.

### 4. Monthly Instalments

- Monthly instalments of 1/12 of your annual subscription will be deducted from your nominated account on the 1st of January via direct debit.
- Please Note: A 10% instalment fee will be applied to your annual subscription.
